### **Objectives and activities**

#### Charitable purposes

Summary of the main activities in relation to these objects

The purpose of the Scout Association is to promote the development of young people in achieving their physical, intellectual, social and spiritual potentials, as individuals, responsible citizens and as members of their local, national and international communities. The method of achieving the aim of the Association is by providing an enjoyable and attractive scheme of progressive training based on the Scout promise and Law and guided by adult leadership

2020/21 has been a tough year for everyone involved with the Scout Group. The leaders reacted brilliantly to the initial lockdown in March 2020 and had Zoom meetings up and running swiftly. The section leaders have put on a wide and varied programme for all the members and when the restrictions were eased worked hard to get face-to-face scouting back up and running after completing all the risk assessments. Over the year the group has awarded over 900 badges covering all sections, a great testament to the hard work the leaders have put in and how the young people have enjoyed the sessions.

The whole Scout Group was aware of how Covid-19 was affecting the local community and the Executive Committee unanimously voted in May to support any families who might be struggling financially. We did not want to see any young person miss out on Scouting opportunities and the mental health benefits of being involved in such activities due to Covid-19.

#### **APPENDIX 1**

### **Achievements and performance**

Summary of the main achievements of the charity during the financial period

- Maintained a detailed balance sheet. Profit of £29,983 is shown for year 2020-2021.
- Support given to members who had been financially affected by Covid-19.
- Successful Gift Aid tax rebate for year 2020-2021 has been included in this year's account.
- Membership has stayed consistent with numbers in the region of 150 young people with 30 leaders and 35 adult members (nonleader, exec committee, etc).
- All sections carried out litter picks which was greatly received by the community.
  - Unfortunately due to Covid-19 regulations we have been unable to offer our usual level of support to local charities and communities but we plan to be back to our usual levels soon after the guidance allows.
- Sections have seen an increase in female members.
- Developed skills of members via a vast range of activities. The section leaders have been highly innovative with content for the online meetings bringing in a number of external presenters throughout the year.
- Continued to invest in the upkeep of the Scout Hall. While renovations have been put back due to Covid-19, plans will progress as soon as the guidance allows.

### Financial review

# Brief statement of the charity's policy on reserves

The Executive Committee (Trustees) believes the reserves held by the Group are ample to maintain solvency and support its aims. The reserves cover the timing between receipts and payments and enable for any reasonable unexpected items of expenditure.

The Group have again agreed to hold 1 years running costs as a reserve. This equates to approx. £25,000.

The Group holds approx. £1,800 for a Camp Fund. They have also set aside an Activity fund to cover program costs i.e. zoom meetings and start up activities after Lockdown. At the end of the financial year this equated to approx. £9,000.

Hall repair work has been agreed to the sum of approx. £5000. This work will now start in the early part of the next financial year. Provisions have also been made for hall floor restoration, painting and new toilets. Approx. £10,000 has been set a side for this work.

Potential purchase of a replacement mini bus has been delayed due to Lockdown but is now on the agenda for consideration. Approx. £15,000 is set aside for this item.

#### Details of any deficit

The Group had an operating Profit of £29,983 in year 2020-2021.

This was an increase from the previous years loss of £2,684.

The primary differences were:

- 1) We received Grants of £14,000 from Business Gateway.
- 2) Our operating costs were significantly reduced due to the hall being closed for most of the year and no indoor face-to-face section meetings were possible due to Lockdown.
- 3) Mini bus was SORN'd in May 2020.

A cash balance of £84,500.61 at  $31^{st}$  March 2021, of which the £4,852.52 is held for the Explorers.

#### Donated facilities and services (if any)

The continual free use of the fenced of land at the rear of the Scout Hall for Scouting activities. The Group pay for professional maintenance of the grounds for the continual use and benefit of the sections.
