Charitable purposes

The purpose of the Scout Association is to promote the development of young people in achieving their physical, intellectual, social and spiritual potentials, as individuals, responsible citizens and as members of their local, national and international communities. The method of achieving the aim of the Association is by providing an enjoyable and attractive scheme of progressive training based on the Scout promise and Law and guided by adult leadership

Summary of the main activities in relation to these objects

2022/23 was a return to more normal activities following 2 years of Covid disruption. The Scout Hall was fully open for weekly in-person meetings and outdoor and external activities recontinued in full.

With the cost of living crisis and the continued fall out from the Covid-19 pandemic the group remains happy to continue supporting those families in need of financial support as we did not want to see any young person miss out on Scouting opportunities and the mental health benefits of being involved in such activities.

APPENDIX 1

Achievements and performance

Summary of the main achievements of the charity during the financial period

- A deficit of £8,620 was made on the year after decisions made by the trustees for the benefit of the charity and our young people to spend existing funds to support the group. For example, purchasing a second minibus at a cost of £28,794 so that leaders from our bigger section can accommodate all young people on activities.
- Gift Aid of £5,342 successfully claimed for 2022/23 memberships and received in May 2023.
- Opened a new Squirrels section for young people of ages 4-6 years old.
- Received a donation from another local organisation of £9,500 for upgrading the Scout Hall which the trustees plan to spend in the 2024 financial year.
- Donated the weekly use of the hall to a local knitting group 'A Good Yarn In The Bay'.

Financial review

Brief statement of the charity's policy on reserves

The Executive Committee (Trustees) believe the reserves held by the Group are ample to maintain solvency and support its aims. The reserves cover the timing between receipts and payments and enable for any reasonable unexpected items of expenditure.

The Group have again agreed to hold 1 year of running costs as a reserve. The equates to approximately £25,000.

Details of any deficit

The group made a deficit of £8,620 in the year which was an increase on the deficit made in the prior year of £4,517. The Trustees took decisions in year to spend some of the built-up reserves to benefit the charity and its charitable work. For example, purchasing a second mini bus at a cost of £28,794.

A further deficit is expected in 2023/24 with the Trustees planning on investing in upgrades to the Scout Hall which are in the process of being planned and costed.

At the end of the year the Group had cash balances of £71,327 of which £7,855 was held by the Explorers section.

Donated facilities and services (if any)

The continual free use of the fenced off land at the rear of the Scout Hall for Scouting activities. The Group pay for professional maintenance of the grounds for the continual use and benefit of the sections.
