Summary of the main achievements of the charity during the financial period

- A surplus of £15,902 was made in the year due to there being no major capital expenditures made during the year. This surplus will be carried forward and used for the future benefit of the charity, for example the Trustees arranged for the aging wooden hall floor to be replaced in May 2024 at a cost of £15,430.
- Gift Aid of £4,919 successfully claimed for 2023/24 memberships and received in May 2024.
- The new Squirrels section for young people of ages 4-6 years old celebrated their 1st anniversary.
- Donated the weekly use of the hall to a local knitting group 'A Good Yarn In The Bay'.

Financial review

Brief statement of the charity's policy on reserves

The Executive Committee (Trustees) believe the reserves held by the Group are ample to maintain solvency and support its aims. The reserves cover the timing between receipts and payments and enable for any reasonable unexpected items of expenditure.

The Group have again agreed to hold 1 year of running costs as a reserve. The equates to approximately £25,000.

The continual free use of the fenced off land at the rear of the Scout Hall for Scouting activities. The Group pay for professional maintenance of the grounds for the continual use and benefit of the sections.
